The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for ESD #6 (EMS & FIRE) from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that ESD #6 (EMS & FIRE) may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for ESD #6 (EMS & FIRE) exceeds the voter-approval rate for ESD #6 (EMS & FIRE).

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for ESD #6 (EMS & FIRE), the rate that will raise \$500,000, and the current debt rate for ESD #6 (EMS & FIRE).

The proposed tax rate is greater than the no-new-revenue tax rate. This means that ESD #6 (EMS & FIRE) is proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 14, 2020 at 6:00 PM at Bracken Volunteer Fire Dept. 23600 FM 3009, San Antonio, TX 78266. Due to COVID-19, the public can dial in telephonically to this hearing and meeting. The dial in number for this hearing/meeting is (978) 990-5000, access code 348563.

The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate. However, the proposed tax rate exceeds the rate that allows voters to petition for an election under Section 26.075, Tax Code. If ESD #6 (EMS & FIRE) adopts the proposed tax rate, the qualified voters of the ESD #6 (EMS & FIRE) may petition the ESD #6 (EMS & FIRE) to require an election to be held to determine whether to reduce the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the ESD #6 (EMS & FIRE) will be the voter-approval tax rate of the ESD #6 (EMS & FIRE).

The following table compares the taxes imposed on the average residence homestead by ESD #6 (EMS & FIRE) last year to the taxes proposed to the be imposed on the average residence homestead by ESD #6 (EMS & FIRE) this year.
