



- Reserve Study – Published/Implemented ESD No 6 Strategic Plan's Reserve Study.
- Interlocal Agreement - Negotiated Interlocal Agreement for area along Hwy 46 and Copper Ridge Community to improve response.
- Outreach - Continued BVFD community outreach (CPR Classes, Fire Inspections, Fire safety presentations at schools and other locations.


Central Station

2021 Action Steps Taken To Achieve Strategic Goals

- 1. Equipment and Facilities Accountability – Implemented accounting and inventory practices for the accountability of ESD No 6 owned equipment and facilities.**
- 2. Reserve Study – Commissioned a Reserve Study to predict lifespan and related expenses for ESD No 6 owned equipment and facilities with funding plan for each tied to annual budget.**
- 3. EMS Attention – Improved inclusion of EMS leadership in ESD meetings and planning; regularly included on commissioner meeting agenda.**

Action Steps Planned To Achieve Strategic Goals 2022

- 1. ISO Rating – Complete a new ISO survey to improve ISO ratings.**
- 2. Response Times – As population grows, with changes from hill country rural and wildland to more suburban settings, improve practices to include use of the Interlocal Agreement for area along Hwy 46 and Copper Ridge Community to sustain and improve response to all portions of the district.**
- 3. Reserve Study – Continue to use Reserve Study to predict lifespan and related expenses for ESD No 6 owned equipment and facilities with funding plan for each tied to annual budget.**
